Statutes of Research Committee

Los estatutos internos de RC 29 deben ser actualizados y armonizados con los estatutos generales de la Asociación Internacional de Sociología, ISA, para cumplir con nuestra obligaciones como comité de investigación y regularizar y armonizar nuestro estatus con todos los requisitos de la asociación.

Las últimas modificaciones fueron aprobadas en Julio 2010. Por este motivo el comité ejecutivo de RC 29 discutió y aprobó un conjunto de cambios que anexamos al presente documento.

Les solicito que pongan atención en los cambios de nueva versión, mismos que se encuentran subrayados en el documento adjunto para que sea más sencillo encontrarlos. Hemos solicitado el apoyo de las autoridades de ISA para que nos ayude en recolectar los votos de la comunidad de RC 29. ISA instrumentará un sistema de voto electrónico para recabar sus votos. De acuerdo con los estatutos de ISA, este documento debe ser aprobado por la mayoría de nuestros miembros para hacerlo efectivo. Se podrá emitir el voto hasta el 22 de febrero, día que llevaremos a cabo el Business Meeting de RC 29 en ISA FORUM.

Revised Statutes of the Research Committee on Deviance and Social Control

Proposed 15 February 2021

RESEARCH COMMITTEE

STATUTES

The Research Committee on Deviance and Social Control (hereafter RC29) was established in 1974 in accordance with Article 4 of the ISA Statutes. RC29 Statutes were first adopted in 1974; subsequent amendments were approved in 2010 and in 2021.

ARTICLE I PURPOSE

1.1 The aim of the Research Committee RC29 of the International Sociological Association is to encourage research of high quality on Deviance and Social Control.

1.2 To establish contacts and to encourage collaboration among scholars working in the field of Deviance and Social Control throughout the world.

1.3 To enhance international cooperation and exchange in theoretical and empirical research in the Sociology of Deviance and Social Control

1.4 To link theoretical and empirical research in the Sociology of Deviance and Social Control, Crime and Violence with related specialist fields or disciplines such as anthropology, psychology, law, economics and juridical studies.

1.5 To act as the international representative body of the sociology of Deviance and Social Control.

ARTICLE II ACTIVITIES

2.1 To fulfil this purpose the Research Committee RC29 engages in the following activities:

2.2 Encourage research among its members and others and serve as a conduit for research, ideas and collaboration internationally.

2.3 Organize sessions at meetings of the ISA.

2.4 Provide information on significant developments in the field through publications and other means such as regular blog, journals, and special conferences.

2.5 Sponsor international seminars of theoretical, methodological or substantive importance and sponsor international training seminars to add to the skills of researchers in the field.

ARTICLE III MEMBERSHIP

3. Members shall be either regular members or affiliated members.

3.1 Regular members shall be individuals or institutions in good standing within the ISA.

3.2 Affiliated members shall be individual or institutions who are not members of the ISA and have been admitted by the research Committee RC29.

3.3 All regular and affiliated members of RC29 shall be entitled to vote in the discussions about organisational matters at the General Meetings according to the principle "one member, one vote" that means that one institution also has one vote.

3.4 All regular and affiliated members of RC29 shall be entitled to:

3.4.1 Participate in the scientific activities of the Research Committee

3.4.2 Receive/access free of charge the Newsletter / website / blog maintained by RC29

3.5. All regular and affiliated members of RC29 shall be obliged to:

3.5.1 Uphold the present Statutes of RC29 and to adhere to the stipulations of the present Statutes

3.5.2 Conscientiously fulfil the tasks entrusted to them by the General Meeting or other bodies of RC29

3.5.3 Pay their fees for the respective period of 4 years. The fees shall be fixed by the RC Board of at each General Meeting for both individual members and organisations. The respective amounts to be paid are specified in the By-Laws to the present Statutes.

3.6. Regular members in good standing with ISA and RC29 will have the right to ask for a certificate or an academic acknowledgement as part of RC29 and recognize their participation at any of their internal forums and events.

ARTICLE IV OFFICERS

4.1 Officers of the Research Committee shall be elected once every four years just prior to the ISA World Congress of Sociology, as stipulated in Article V.

4.2 The composition of the Board shall be:

President  
Vice President(s)  
Secretary  
Treasurer

**At least three and a maximum of seven Board Members representing at least three world regions reflecting the regional composition of the RC29 membership.**

Ex-officio Former President(s)

**4.3 The term of office  
President: maximum 7 terms (stipulated by the ISA)  
Officers (Vice-Presidents, Secretary, and Treasurer): no more than 3 consecutive terms (stipulated by the ISA)  
Board Members: Maximum 2 consecutive terms and no more than 3 terms (established by RC29)**

#### ARTICLE V ELECTIONS

5.1 To ensure participation of all regular and affiliated members, nomination shall be done by email. The Secretary shall prepare a form to be sent to all regular and affiliated members at least sixteen weeks before the election day together with a list of all regular members of RC29.

5.2 All regular and affiliated members of RC29 shall be entitled to nominate candidates for the Board. Nominated candidates shall be regular members of RC29. They shall confirm their preparedness to accept the respective position on the Board in case they are elected and to remain a regular member in good standing of the ISA and of the RC for the duration of their mandate, and shall return the signed nomination form to the Secretary, together with brief curriculum vitae.

5.3 The Secretary shall prepare a ballot listing all nominated candidates along with the respective positions on the Board. In case of several nominations for the same position, the nominated candidates shall be listed in alphabetical order. Pairs of candidates may also be nominated for the positions on the Board to function as Co-President, Co-Secretary/Treasurers, etc.

5.3.1 The ballot shall be sent to all regular and affiliated members of RC29 by email at least ten weeks before the election day.

5.4 Regular and affiliated members shall send their ballot by email to the designated electoral officer(s). Ballots received later than two weeks before the beginning of the World Congress shall not be counted.

5.5 The candidate receiving the highest number of votes cast will be deemed elected to each office.

5.6 An election shall be valid if more than one third of the membership votes.

#### ARTICLE VI BOARD

6.1 The officers listed in Art. IV constitute the Board

6.2 The Board is entrusted with the direction of the activities of the Committee and to nominate a representative (and one alternate) to the Research Council of the ISA.

6.3 Major new activities undertaken by RC29 must first be approved by the Board.

6.4 The Board shall identify the themes and topics for a World Congress of Sociology and at least one mid-term conference and take responsibility for the organization of those sessions.

6.5 The President

6.5.1 The President will preside over meetings of the Committee and its Board

6.5.2 The President will initiate and carry out policies in conformity with RC29 purposes as specified by the Board and the membership.

6.5.3 The President will be responsible for seeing that sessions of RC29 at the ISA meetings are organized.

6.6 The Vice-President(s) will assist the President and conduct activities delegated by the President. They may also be assigned special duties by the President.

6.7 The Secretary is responsible for communicating RC29 activities and plans to the members twice a year through the Newsletter / blog.

6.8 The Treasurer is in charge of distribution of funds under the supervision of the Board to which s/he presents annual report.

6.9 Each member of the Board must at all times be a member in good standing of the RC29 and of the ISA.

6.10 The places of any Board member not in good standing with either the ISA or RC29 may be declared temporarily vacant by the President, at the President's discretion, and the vacancy filled according to article IV.

6.11 Temporary vacancies in the Board between consecutive ISA World Congresses may be filled by appointment by the President, in accordance with ISA Statute 4.5: "If casual vacancies arise in an RC, WG or TG Board between elections, they may be filled by appointment by its President unless its Statutes provide an alternative mechanism; if the vacancy is for President, the Secretary in consultation with other Board members may take action."

6.12 One of the Board members, identified by the Board, will assume the

responsibilities of the President in the case of the death, incapacitation, resignation, or other inability of the incumbent to carry out the responsibilities of the office of the President.

#### ARTICLE VII GENERAL MEETING

A General Meeting of RC members shall be held in conjunction with the ISA Meeting.

7.1 Announcement of the General Meeting will be made to the members at least three months in advance, together with a tentative agenda of business.

7.2 A written petition of twenty members to the President within six months after the General Meeting can institute a mail ballot to the membership on any issue presented at the general meeting. The Board, by majority, can also institute a mail ballot to the membership at any time.

#### ARTICLE VIII REVISION OF THE STATUTES

8.1 Proposals for the revision of the Statutes may be submitted in the membership upon written petition of twenty members to the President, or a resolution of the Board.

8.2 Revision requires approval by a majority (51 per cent) of the whole membership in an email ballot.

#### BYLAWS

RC29 affiliation fees are fixed at USD 30 for a 4-year period for residents in countries in A and B (categories established by ISA), USD 20 for countries in category C, and USD 15 for students.

Marielle Franco was a 38-year old Brazilian sociologist, a single mother, a defender of human rights and a local counselor of the city of Rio de Janeiro. She was murdered on March 14th 2018. Ever since, she has become a global symbol of a struggle against racist, colonial, hetero-patriarchal domination and police violence and for social justice, human rights and democracy.

Sociology played indeed a major role in this path towards emancipation, as she attended classes in her favela and then graduated at the university. She kept a career as a sociologist, a social activist and a political actor until the end, as she was in charge of a report on military violence in Rio's favelas, which is the most probable reason of her assassination.

## CONVOCATORIA POR INVITACIÓN A LA REVISTA *CIFE: LECTURAS DE ECONOMÍA SOCIAL*

### "Ilegalidad, violencia y delincuencia en América Latina: manifestaciones y respuestas"

Cada vez más, el delito tiene un lugar significativo entre las agendas públicas, políticas y privadas en todo el planeta. Sin el incentivo de contrainformación y buena fe, se han desplegado, desde distintos niveles (como la academia, las respuestas ciudadanas y las políticas públicas), una serie de mecanismos que le dan respuesta y conjugan su momento a escala global. Por parte de la ciudadanía, la población ha respondido con medidas básicas de seguridad motivadas por el miedo y hartazgo, como el cierre de calles, la instalación de rejas y candados, la amenaza explícita a los posibles delincuentes, la compra de armas, entre otras. A su vez, por parte de las políticas públicas, las respuestas diseñadas para enfrentar la ilegalidad, el delito, la violencia y la delincuencia han ido desde el despliegue de las fuerzas armadas hasta instrumentos de prevención del delito que garantizan la seguridad ciudadana. Desde la academia se ha impulsado una agenda de investigación donde se observan, en un primer momento, los estudios relacionados al tráfico de drogas, pero que se han venido diversificando, dando cada vez respecto más centralidad a un problema que tiene múltiples aristas.

El interés por el delito, y por lo tanto, por la garantía de la seguridad ciudadana, adquiere mayor relevancia en el contexto del continente americano, debido a que, comparativamente, se lo percibe como el más violento del planeta. Por otro lado, si desagregamos los datos sobre la información referente al homicidio intencional, visto como el referente emblemático de la actividad criminal al tener un subregistro considerable tanto como observables, a escala regional, encontramos que América Latina es la región con mayor incidencia delictiva a nivel mundial, pues es el territorio donde la estadística de homicidio ha crecido por arriba de la media internacional (*Informe Global de Homicidio, 2019*, pp. 14-22).

Por ello, resulta imprescindible repensar la problemática de ilegalidad, violencia y delincuencia, sus manifestaciones y respuestas en América Latina. Más que reafirmar de manera invariable sobre lo antes dicho por parte de la academia sobre el tema, lo que se propone es ampliar la mirada hacia el contexto específico de América Latina, región caracterizada por la politización y la multiplicidad de variables, culturas, sociales, políticas y económicas. Así, un problema de diversas causas y manifestaciones, en una realidad que se distingue por la multiplicidad, requiere de variadas respuestas. En ese sentido, hay varios ejes temáticos que se deben estudiar para la región, como la prevención del delito, desde la ejecución de políticas públicas hasta la participación activa de la población civil en busca de medidas que finalicen sus hábitos delictivos, el entramado de relaciones culturales, como la construcción de un orden social ilegal a partir de estructuras simbólicas al interior de grupos criminales; los mercados ilegales,



presentes en toda la región, que pueden ir desde la piratería, la extracción y explotación de recursos naturales y la explotación de fuerza obrera, con su respectiva importancia ecológica, la participación ciudadana, ya sea en la conformación de grupos de autoayuda cívica o incluso en la organización participativa en medidas de acondicionamiento y dotación de bienes y servicios dentro de sus comunidades; la implementación tecnológica en el despliegue de políticas públicas, como el despliegue de circuitos de monitoreo en zonas urbanas con alta concentración de violencia y delincuencia; los factores asociados al delito, como el nivel educativo, el acceso al consumo de alcohol y otras sustancias, los índices de pobreza y marginalidad, etc.; entre otros.

Por lo tanto, la presente convocatoria pretende reunir un sólido corpus de textos científicos, con una consistente base metodológica asociada al tema, que apelen a esa multiplicidad de factores, vistos desde distintos acercamientos epistemológicos y desde distintas perspectivas. Así pues, se invita a la comunidad científica, experta en la materia y pública internacional que colaboren en el número especial de la *Revista CIFE: Lecturas de Economía Social*, en su número especial dedicado al problema de la ilegalidad, violencia y delincuencia en América Latina, sus manifestaciones y respuestas, con temas relacionados a:

The spread of tools and applications for remote communication ranks among the most significant innovations induced by the pandemic. This revolution, if not in technologies at least in uses, has reached prisons, where for the first time - at least in Italy - the broadcast of video calls and the use of the network for education and training activities has become common, although the use of the latter is still rather marginal.

It was a breakaway change from the traditional distrust of the penitentiary institution towards the network and information technologies, explicitly motivated by generic crime prevention measures, implicitly by the principle of less eligibility, so that inmates cannot be allowed this, which is commonly used in external life.

These openings to the use of the network and information technologies for the benefit of inmates have been counterbalanced by limited face-to-face relationships with family members, lawyers, volunteers and teachers, as well as in the further spread of remote participation in judicial procedures, which has provoked a greater segregation and isolation of the detainees.

Our magazine, aiming to consolidate the presence of ICTs in the penitentiary domain, is interested in investigating the strategic and / or cultural reasons for the distrust of operators and the administrations of justice towards them, their ambivalences between communication and control opportunities / isolation of prisoners, their applicative potential for the benefit of prisoners (from telemedicine to procedures for accessing social and personal services, from the use of the Internet in training,

education and knowledge courses, to that of e-mail for correspondence, the possibilities of participating in videoconference hearings).

This monographic issue of Antigone aims to collect essays that address the issue of information technologies in prison from various disciplinary angles. We therefore intend to enhance both theoretical and practical contributions, linked to the Italian, European and extra-European context. In this regard, contributions in Italian, English, French or Spanish are accepted.

Authors who intend to submit a contribution to the monographic issue are invited to send an abstract - between 300 and 500 words - no later than 31/03/2021 to the following email addresses: perla.allegri@unito.it, stefano.anastasia@unipa.it, vincenzo.scalia@windschster.ac.uk, redazione@associazioneantigone.it;

#### **Police, Courts, and Incarceration: The Justice System and the Family**

Contemporary Perspectives in Family Research, an annual series which focuses upon cutting-edge topics in family research around the globe, is seeking manuscript submissions for a special volume. The volume will focus on the theme of **'Police, Courts, and Incarceration: The Justice System and the Family.'**

On a daily basis, around the globe, millions of individuals are entangled in justice systems either as offenders, as victims, or vicariously as family members of those directly involved. Contact often begins with the police that frequently leads to court involvement, and for offenders found guilty, to correctional supervision or incarceration. While these encounters primarily affect individuals, they have a tremendous impact upon the family. Police and justice entanglements can result in tremendous strains upon families economically and socially, and can also endanger family relationships. In doing so, we are seeking articles that cover a wide array of topics including: how policing, arrest, jail and court processes impact family members and their support networks; how prolonged incarceration impacts children and parenting processes and family coping; how intimate relationships are impacted during and after incarceration including marriage and divorce and partner violence; and, whether system involvement leads to unintended consequences among family members such as heightened fear of crime and victimizations including extrajudicial killings and fears of the police, among others.

This volume of CPFR will be coedited by Sheila Royo Maxwell of Michigan State University and Sampson Lee Blair of The State University of New York (Buffalo). Manuscripts should not exceed approximately 40 double-spaced pages (not including tables, figures, and references). Submission of a manuscript implies commitment to publish in CPFR. Manuscripts should adhere to the APA format. Manuscripts should represent previously unpublished work. An abstract of 150-250 words should be included at the beginning of each manuscript. All manuscripts will undergo peer review.

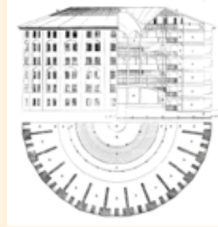
