## Report on the Amsterdam conference

The conference was held on May 16-18, in the congenial surroundings of SISWO and Amsterdam. As members will have noted from previous newsletters, sufficient papers were offered for parallel sessions to be held throughout - which inevitably created some dilemmas about which to attend. A few potential paper-givers were unable at the last minute to come, but despite that there were 52 papers, which shows how active members are. It was particularly pleasing to note that at least 18 nationalities were represented, and that there were several students present and playing an active part in discussions.

A well-attended business meeting was held, at which the most important item was the discussion of our potential programme at the World Congress; the sessions proposed are listed below.

The group to evaluate the applications for the Leo P. Chall Dissertation Fellowship was chosen: it is to consist of Dirk Käsler, Denes Nemedi and Stephen Turner.

The secretary reported that the financial situation is generally healthy, though the propensity of some members now to pay RCHS early when renewing their ISA membership may be creating a misleading picture. There is not sufficient in the bank to offer systematic support to members who have difficulty in raising the money to come to meetings, but occasional help should be possible for those from soft-currency countries. Members were urged to submit their news items and announcements to the secretary for the newsletter.

The need for nominations of new Board members in time for elections before the World Congress was mentioned, and the tasks and workload involved were discussed. (Any members not present at the meeting who might be interested in standing are invited to ask the secretary anything they would like to know about this. A nomination form will appear in a subsequent newsletter.)

Finally, Dick Pels, his helpers, and SISWO, were warmly thanked for their excellent organisation and care during the conference.

### World Congress: Montréal 1998

It is time now to start thinking about the sessions we would like to organise for the World Congress. When all the proposals members wish to make are available, decisions will be made about which ones to adopt given the number of timetable slots that have been allocated to us; it may be suggested that proposals of closely related interest might be combined. Any paid-up member(s) may make a proposal; it is understood that members making a proposal are volunteering to take responsibility for organising that session. This involves providing a short 'call for papers', taking any steps to recruit participants as well as receiving offers of papers from the membership generally, deciding on the papers to be included, transmitting the instructions passed on by the Secretary to the participants, sending the information required to the Secretary by the deadlines specified, and chairing or arranging for the chairing of the session at the Congress. It always takes a long time to prepare a World Congress programme, so lists of sessions and papers have to be provided well in advance; we do not yet know the official deadlines, but most of the organisational work may be expected to occur in 1997..

First proposals for possible session topics, made at the Business Meeting at the Amsterdam conference or since, are listed below. If any other member is strongly interested in one of these, and might like to help organise it, or to propose modifications to the formulation of the topic, they should contact the proposer and discuss the matter with them, and the Secretary should be informed of the outcome.

# *Further proposals, or modifications to these proposals, should reach the secretary by no later than October 1, 1996.*

Where a short explanatory paragraph has not already been provided, that should be included. (It would be extremely helpful, though it is not essential, if this could be provided on disk in a form usable by Word for Windows 6.) It will then be possible to provide a complete final list in the next newsletter.

#### **Proposed sessions and organisers**

# **Construction of sociological knowledge in the colonial setting** (Frank Furedi and Lyn Schumaker)

This session would consider the history of sociology's encounter with colonial societies. Subjects such as the role of metropolitan research institutions, local centres of research, the role of indigenous knowledge, the origins of concepts and theories used to discuss colonial societies are some of the themes to be considered.

# In search of a 'good society': the concept of sociology as a 'moral science' in the history of sociology. (Dirk Käsler and Maarten Mentzel)

The different courses of the concept of sociology as a scholarly enterprise to formulate scientific designs for the 'good society' in different national traditions; the historical processes of the 'scientific turn' after which even the idea of sociology as a 'moral science' was banned as unscientific; where does sociology stand in this discussion as we approach the 21st century?

#### National sociological associations (Jennifer Platt)

National sociological associations have been given little attention in the history of sociology, but they play a significant role in it both organisationally and intellectually, though that role has differed considerably from one country or period to another. This session will attempt to compare different associations and to relate them to their social contexts. The issues raised may range from their internal organisation and membership to their external political roles, and will include both their intellectual functions and their concern for such matters as research funding and members' employment. (A detailed list of topics which it might be relevant to cover will be circulated to those interested.)

**Histories of the use of sociological concepts in sociological research** (Martin Bulmer) Concepts mediate the relationship between theory and empirical research. The focus would be on the history of such use of particular concepts; examples could include anomie, social cohesion, charisma, social class, party self-identification, self-reported illness, poverty, religious belief. Discussions of any suitable concept would be considered.

**Interconnections between early sociology and social policy** (Rosalind Sydie) The interventions of early sociologists in the practical, political arena of social policy.

#### Gunnar Myrdal (Sven Eliaeson)

Myrdal was born in 1898 (so the Congress will mark his centenary); little work has been done on him yet, and there is rich source material which has been little utilised. Themes which could be explored include the following: He played a quite significant role in the diffusion of some important strands of thought, carrying Chicago School concepts to Sweden and instrumental policy analyses in the vein of Weber and Rickert to the USA. He was influenced by both Weber and Axel Hägerstrom (Scandinavian legal realism). His career manifests the role of American philanthropy in the development of European as well as American social science.

#### Hegel's social theory (Christopher Adair-Toteff)

Despite the numerous references to Hegel in sociology and social theory insufficient attention has been paid to his ideas. This session would be devoted to helping to rectify this situation. Hegel is a dialectical thinker, and that means in part that he is one of the foremost thinkers who had a deep and abiding interest in social interaction at all levels. Topics in this session might include Hegel on recognition, on the family, the community, the society and the state, as well as his influence on sociological traditions.

# The history of sociology and the stabilisation of disciplinary identity (Paolo Barbesino and Salvino Salvaggio)

The debate around postmodernism has shown to what extent sociology is still far from being capable of drawing its boundaries towards either other social science disciplines or the free floating discourse of public opinion. This lack is often filled by resorting to the history of sociology as a way of stabilising a specific disciplinary identity. The session should therefore aim at investigating the role of the history of sociology by both mapping out the development of different historiographies and questioning the performative function of their narration. In this light, a particular emphasis should be given to the constitution of a disciplinary canon and to the role attributed to the 'founding fathers' within it.

Studies and restudies of communities (Jean-Michel Chapoulie)

What can we learn from such studies about the history of sociology? This could be approached through looking at either classic one-off community studies, or restudies.
