#### **President's Message**

Greetings from India and Ishwar Modi! Here comes to a close my second term as President of ISA RC 13. As such this is my last message to you in this role and position. I need not overemphasize that during this period our Research Committee has grown from a very small RC to the select largest ones. From a meager membership of a little more than 30 in 2006, its membership touched the magnificent mark of 200 members from more than 40 countries spread over all the continents at one stage during this period. As such, RC 13 also became entitled to hold 22 sessions / joint sessions at the forthcoming ISA World Congress of Sociology in Yokohama, Japan, while it was allowed to hold only 6 sessions at the ISA Congress in Durban in 2006. I would also once again like to emphasize that RC 13 during this period has regularly been organizing its midterm conferences or organizing its sessions at the ISA Forums or the ISA Congress since 2008. Participation of RC 13 members as well as that of other scholars has almost constantly been increasing. While publications out of the presentations made at the midterm conferences in Beijing (2009) and Palermo (2011) have already been brought out in the form of books, the work on the publication based on the presentations at the midterm conference in Szeged, Hungary (2013) is in the process. Besides the above, you may also look forward to more publications based on the presentations (with additional invited papers) made at other Forums/Congresses. An additional effort is now being made to bring out a journal of its own by RC 13 through an internationally acclaimed publishing house.

In order to encourage young scholarship in the field of Sociology of Leisure, a Young Leisure Scholars Award was also instituted by RC 13 during this period, and though the results have not been very encouraging, off and on, young scholars have been submitting their papers for the competition and also have been chosen for the award.

All this could become possible because of the wholehearted support of the stalwarts and eminent scholars and functionaries of ISA RC 13 as well as that of the widespread membership of RC 13. As a token of its appreciation and gratitude for strengthening and leading ISA RC 13 by the former ISA RC 13 Presidents, RC 13 honored its former presidents Professors Anna Olszewska (1978-1986), Stanley R. Parker (1986-1990), Teus J. Kamphorst (1990-1994), Gilles Pronovost (1994-1998), Kenneth Roberts (1998-2002), and Francis Lobo (2002-2006) "in appreciation and recognition of their continuing contributions to the advancement of sociology of leisure" by presenting Mementos on the occasion of the ISA World Congress of Sociology in Gothenburg, 2010. It was ensured that the former presidents, who could not make it to Gothenburg, were honored and presented the mementos at their native places. I myself found the opportunity to honor the senior most living former President of ISA RC 13, Prof. Anna Olszewska in Warsaw, Poland. She expressed her happiness that she is still being remembered with affection and gratitude.

I would like to place on record my heartfelt thanks to the RC 13 former Presidents, Professors Teus J. Kamphorst, Kenneth Roberts and Francis Lobo for asking me to accept to be the President of ISA RC 13 at the ISA Congress in Durban, 2006 and for my unanimous election to the position. All of them, all the Board Members, as well as all the members of RC 13 have extended their wholehearted cooperation to me in the functioning and strengthening of ISA RC 13, and I will remain thankful to all of them for this kindness. My special thanks to Prof. Francis Lobo for seeing through the ISA RC 13 Board Elections once

again unanimously at the ISA World Congress in Gothenburg 2010. I do hope he will bear this responsibility in Yokohama as well.

After my functioning as President of ISA RC 13 for the two terms of 2006 – 2010, and 2010-2014, I firmly believe with conviction that the Research Committee on Sociology of Leisure has a bright and vibrating future. It must continue to explore its collaborations with other research committees of the ISA at all the future Forums and Congresses of the ISA. My experience of working with more than a dozen ISA RCs has been most fulfilling and rewarding. I would once again like to place on record my high appreciation for their very supportive collaborations all through my tenure as President of ISA RC 13.

Friends, I am now keenly looking forward to meeting many of you at the ISA World Congress of Sociology in Yokohama, Japan, July 13-19, 2014 and to interacting with you at the large number of sessions and joint sessions of RC 13. The Program of these sessions is attached in this newsletter.

Thanking you once again for your wholehearted cooperation to me and to meeting many of you in Yokohama.
