Michel Bassand and Artur Meier

The Task Force of the Publications Committee met on January 21-22 in London, England. The meeting was attended by: Margaret Archer, Michel Bassand, Tom Bottomore, Guido Martinotti, Artur Meier, David and Katy Brooks, and Kurt Jonassohn.

The Committee reviewed the affairs of the SSIS books, the Journal, the Bulletin, and the membership of the Editorial Boards.

The books in the Sage Studies in International Sociology series are doing very well. The first volume already had to be reprinted. By the end of this year, 14 volumes will have been published. A number of early proposals were dropped, mainly because no manuscripts were received. Of the outstanding proposals, five were accepted for possible publication in 1978. The Task Force was unwilling to make further commitments because it did not want to risk a delay in the publication of materials from the 1978 World Congress. The Editor has already been in touch with the organizers of sessions in the World Congress program to encourage some of them to submit proposals for volumes to be based on their sessions. Some replies have already been received and more are expected as progress is made on the detailed organization of program sessions.

The Journal Current Sociology is still in some difficulty with regard to bringing its publication schedule up-to-date. But it is hoped that this situation will soon be resolved. Volumes XXII and XXIII were reported to be at the printers and should be available to subscribers in the near future. The first two numbers of Volume XXIV have appeared and are being mailed to subscribers now. A large number of proposals for future numbers were reviewed and approved by the Task Force. This should assure a flow of manuscripts that will keep the presses rolling on time.

The ISA Bulletin, which is produced by the Secretariat as a service to ISA members, will not be made available on a subscription basis. It was decided to make it available to a very limited list on a complimentary basis. Because it will remain a medium of communication with the membership, it will in future attempt to carry more reports on ISA activities including reports from the Secretariat and financial reports - space permitting.

Finally, a list of suggested names was prepared for the consideration of the Executive Committee in May to replace members of the Editorial Board of SSIS who are not interested in serving another term.

The meeting expressed its gratitude to David and Katy Brooks for making the local arrangements for the meeting and for their hospitality.

Le groupe de travail du Comité des Publications se réunissait les 21 et 22 janvier à Londres. Étaient présents: Margaret Archer, Michel Bassand, Tom Bottomore, Guido Martinotti, Artur Meier, David et Katy Brooks, et Kurt Jonassohn.

Les thèmes suivants furent discutés: les volumes de la série "SSIS", la Revue, le Bulletin, et les membres des comités éditoriaux.

La série "Sage Studies in International Sociology" se vend très bien. Il a déjà fallu ré-imprimer le premier volume, et on prévoit que 14 volumes en tout auront paru avant la fin de l'année. De toutes les propositions qui avaient été envisagées, certaines ont dû être abandonnées par manque de manuscrits. D'autres excellents textes ont aussi dû être rejetés, malheureusement, car le groupe de travail ne tenait pas à prendre des engagements qui pourraient retarder la parution de volumes ressortant du IXe Congrès Mondial. Cinq propositions furent acceptées; celles-ci paraîtront probablement en 1978. L'éditeur de la série "SSIS" s'est déjà adressé aux responsables de plusieurs sessions du Congrès afin de les encourager dès maintenant soumettre des propositions pour des volumes basés sur le travail de leur propre session. Certains ont déjà répondu, et on attend d'autres réponses au fur et à mesure que les sessions s'organiseront d'une façon plus définitive.

Nous avons encore des difficultés à rencontrer les prévisions de publication de la revue "La Sociologie Contemporaine". Toutefois, cette situation devrait s'améliorer bientôt, car, d'après les dernières informations reçues, les volumes XXII et XXIII sont sous presse et seront disponibles d'ici peu. Par contre, les deux premiers numéros du volume XXIV ont déjà paru et seront distribués aux abonnés très prochainement. De nombreux projets de textes pour les prochains volumes de la revue furent étudiés et approuvés, afin d'assurer une quantité suffisante de manuscrits pour éviter tout retard à l'avenir.

Il fut décidé que le Bulletin de l'AIS, qui est publié par le Secrétariat et représente un service de la part de l'AIS à tous ses membres, ne serait pas distribué sur abonnement. Il sera envoyé, à titre gratuit, à un nombre restreint d'intéressés. Vu que le Bulletin reste l'organe principal de communication entre l'AIS et ses membres, il contiendra autant que possible, dans la limite de l'espace dont nous disposons, des rapports plus détaillés sur toutes les activités de l'AIS, y compris des rapports du Secrétariat et des rapports financiers.

Le groupe de travail rédigea une liste, qui devra être approuvée par le Comité exécutif en mai, qui remplacera certains des membres du Comité éditorial de la série "SSIS" qui se désistent de ce Comité.

Katy et David Brooks furent remerciés de s'être occupés de l'organisation de la réunion, et de leur chaleureux accueil aux participants.

Report of Activities:

During the year 1976 the Research Committee on Armed Forces and Society continued to promote the study and analysis of contemporary developments in this area of research. The year's work began with the publication of the proceedings of the Toronto Conference held in 1974. A selection of the papers which were presented at the Eighth World Congress of Sociology were published by Sage Publications as a volume in the Sage Studies in International Sociology:

G. Harries-Jenkins and Jacques Van Doorn (Eds):  
The Military and the Problem of Legitimacy.

The volume received favourable reviews in the U.S. and the U.K. and it has been referred to in a number of subsequent papers.

In May 1976, a regional conference was held in Copenhagen on the topic of "The United Nations and Peacekeeping Activities". The conference was attended by more than 30 scholars from Western Europe and the U.S. and valuable contacts were developed between academic scholars and practitioners in the field. The conference stimulated further research in this important area which has attracted considerable interest.

Following a mailed ballot to all paid-up members of the Research Committee, a new board has been elected. T.N. Clark and K. Newton have been re-elected as chairman and secretary.

Given the increases in travel costs and decreases in grant and travel funds, the Research Committee has increasingly sought to arrange meetings in conjunction with other organizations. Since its last annual report, the Committee has accepted 17 new members representing sociologists from Belgium, Canada, Israel, Philippines, Poland and the United States. Membership now includes 128 individuals from 18 countries.

In July 1976, a workshop on Ethnicity and Development was held in Singapore. Organized by Dr. Riaz Hassan, a member of the Executive Board of the Committee and by Dr. Jacques Amyot of the International Development Research Center, the workshop included social scientists from 5 Southeast Asian countries.

In November 1976, a conference was held in Washington, D.C. on "The New Immigration: Implications for the United States and the International Community". Organized by Roy S. Bryce-Laporte, a member of the Committee and Director of the Research Institute on Immigration and Ethnic Studies at the Smithsonian, the conference was sponsored by the Smithsonian Institute. *Report of Activities:*

The Research Committee, with a nominal membership of 75, pursued its aims first: by keeping each other informed through a circular sent out by its chairman Orlando Fals Borda at approximately 3 months' intervals, and second: by organizing in September a regional meeting for Europe in Zurich, Switzerland, which 20 persons attended.

It had been able to publish in January a selection of the papers presented at the Research Committee sessions during the Toronto World Congress in the form of a special issue of the International Revue of Community Development as was announced in the ISA BULLETIN of Spring 1976.

During the year, Orlando Fals Borda has been mainly concerned with organizing a second world-wide symposium which will take place in Cartagena, Colombia, on April 18-24, 1977. He has received proposals for papers on the theme of Action-Research from a large number of sociologists from South America, North America and Europe, Africa, Asia, Australia. Particulars on the arrangements, so far, can be found in ISA BULLETIN #11.

At the present time, preparations are being made for the publication of some of the papers presented at the Zurich meeting. Since two publishing houses expressed interest, it is not as yet clear what kind of anthology will be realized exactly. The focus of this new venture, however, will be on Innovative Processes in Highly Industrialized Nations.

In Balatonszeplak (Hungary) took place (26-29 September 1976) a conference on Sociology of Law and Legal Sciences. The theoretical introductory lecture of the conference was held by Prof. Imre Szabo, vice-president of the Hungarian Academy of Sciences, with the title: "Theoretical-methodological relationships between the Sociology of Law and Legal Sciences". Another main topic was "Law and Economic Order". There were also sessions on Documentation in the field of Sociology of Law, the Teaching of Sociology of Law, Knowledge and Opinion about Law, Theoretical Hypotheses of the Sociology of Law.

A meeting is to be held in Saarbrücken in September 1977. The main topic will be "The Impact of the Research in the Field of Sociology of Law on Government Action". According to the interests of the members, round tables will be organized. Thought has been given to organizing special sessions by the working groups of the Committee. (Knowledge and Opinion about Law, Documentation on Sociology of Law, Theoretical Hypotheses in Sociology of Law).

*Report of Activities:*

L'année qui vient s'avère de grande importance pour le comité; voici, brièvement, quelques indications sur les tâches à accomplir:

Préparation du prochain congrès de l'Association Internationale de Sociologie, Suède, 1978: la première étape consiste à établir un échéancier de travail concernant les communications qui seront présentées au congrès; à cet effet, le comité exécutif, formé du président, des vice-présidentes et du secrétaire, s'est adjoint M. Swedner, de la Suède; le prochain bulletin devrait contenir des informations détaillées à ce sujet. Il reste également à contacter d'autres groupes de recherche de l'AIS en vue d'éventuelles sessions conjointes.

Préparation d'un projet de statut pour le comité. A cet effet le secrétaire entreprendra un bref sondage auprès de certains membres du comité, avant de soumettre au comité exécutif un avant-projet de charte, lequel, après discussion, pourra être soumis à l'ensemble des membres.

Confection d'un bref questionnaire, à envoyer à tous les membres, de façon à publier en 1977 une brochure spéciale présentant l'inventaire des membres du comité.

Relations internationales: le comité demeure en contact avec diverses institutions, nationales ou internationales (World Leisure and Recreation Association, Fondation Van Clé, etc.); mais il reste à intensifier ces relations, et à faire connaître davantage le comité; un projet de brochure spéciale d'information, sur le comité, est en préparation.

Recherches et publications: C'est la tâche principale du comité que de promouvoir la recherche et la publication en matière de loisir. A cet effet le comité coopère à un projet d'étude comparative internationale sur le loisir. De plus, des projets de publications des travaux des membres sont à l'étude.

*Report of Activities:*

A meeting of the Board of the Committee was held in Paris on December 6, 1976. After having discussed the identity and role of the Committee, especially in relation to other international organizations dealing with the same problems (IAMCR, ICI, ICA, WAPOR), the desire was expressed to work towards promoting contacts and initiatives with these and other bodies that might be interested in fostering studies and research in this area. At the same time the Board debated the problem of reconsidering the disciplinary sphere of the Committee and decided it would be advantageous to widen the Committee's interests to the spheres of the Sociology of Culture and Knowledge.

The Board also considered the possibility of officially recognizing the existence of national groups that spread the initiatives of the Committee at a local level. However, it was decided to put off any official decision until Uppsala, and to encourage the informal formation of groups and, for the moment, to urge the personal support of ISA and Committee members.

Several decisions were then taken regarding the future activity of the Committee up until Summer 1978:

First, it was agreed to prepare a new series, to be published at regular intervals - as a rule every three months - of a Newsletter to inform of the Committee's activities and of any initiatives or news that might be useful to Committee members. The Newsletter will be edited by the Committee secretary to whom all requests, suggestions and any news or items that could contribute to improving the Newsletter should be addressed. The first, experimental, issue will be sent to members by the end of January 1977.

The Newsletter will also contain suggestions for the organization of the works to be presented at the next World Congress of Sociology. In particular, the Newsletter will try to link, as far as possible, the works of the Symposium (two meetings on the subject "Mass Media and Social Change") and the four meetings of the Committee.



The object of these meetings, with the exception of the last which it will be opportune to leave open in order to debate the future activities of the Committee and any organizational problems, will be decided in two earlier meetings to be held respectively in Italy (Trento) and Portugal (Lisbon).

These latter meetings will take place in 1977. The one in Trento (Italy) will be held in May 1977 and will discuss two subjects: "Organization and Creativity in Mass Media" - "Inventory and Prospects in Mass Media Research: the role of the International Committee on Mass Media".

The two subjects will be organized on the basis of essays presented by rapporteurs appointed by the Board of the Committee. The University of Trento is planning a series of facilities for those participating in the encounter.

The one in Lisbon (Portugal) is planned for September 1977 and the subject will be "Popular Alternatives to Mass Communication". In this case too a specially appointed scientific committee will take care of the task of inviting the rapporteurs for the introductory essays. The organizational details will be published in one of the Newsletters to come.

At the Committee meetings in Uppsala there will be a discussion on the outcome or proposals for research activity that emerge from the two congresses in Trento and Lisbon.

Fuller details of the items mentioned in this report will be given in the 1977 newsletters. All those interested in the Committee's activities are invited to write to the editor of the Newsletter both to advise of other activities or news and in order to receive the Newsletter opportunely.

*Report of Activities:*

The Committee has continued to remain very active in 1976. It has supported and been responsible for the initiative in holding both national and international meetings this year in Boston, Paris and Louvain. The Committee has also continued its dialogue with the World Health Organization over issues of interest to both organizations. The ISA is affiliated to the WHO as a non-governmental organization. The Research Committee represents the interest of the ISA with WHO and has a permanent representative based in Geneva who is able to attend on a regular basis, all meetings of the WHO committee and plenary sessions relevant to medical sociology. In addition to our permanent representative in Geneva, Prof. Manfred Pflanz undertakes the major responsibility for preparing reports and making representation to the WHO as required. The president of the committee, Dr. Mark Field, has been pursuing with WHO future activities and mutual cooperation between the two organizations. At present, the secretary of the Committee is preparing a list of the membership characterized by research skills and interests which then will serve as a mechanism for advising WHO of individuals and institutions who may be of use to them when the World Organization is pursuing a particular problem in health care organization or delivery which may require the input of medical sociologists for its resolution.

In addition to the activities outlined above, this year has seen the publication of two books arising from previous international meetings prompted and held under the auspices of the Committee. The organization of an international symposium usually imposes a tremendous burden upon the host country and institution and members of that institution that take responsibility for organizing such meetings. Those who attend such meetings usually derive very considerable benefit from the encounters but the number of people involved is necessarily limited because of the expense incurred by such activity. It is particularly gratifying to note that the results of these international meetings are now available in print and Profs. Pflanz and Sokolowska are to be congratulated for making these materials available to a wider audience.

Report of Activities:

The Committee's activities during 1976 can be classified under three headings: the Messina international conference, the preparation of the first three issues of the International Journal of Urban and Regional Research (IJURR) and other publications, the constitution of national sub-committees in the USA, France and Great Britain.

Copies of the list of participants at the Messina conference as well as the list of papers are available for Committee members from the secretary.

The first issue of the International Journal of Urban and Regional Research will be published in February 1977. The journal is international and interdisciplinary. It will publish critical and comparative papers on urban and regional developments throughout the world. It will be concerned with the analysis of the social basis of different forms and strategies of planning and state intervention. The journal will encourage comparative research on the diversity of patterns of urbanization. A major focus will be the examination of emerging alternative structures. The journal will be divided into four sections:

- major articles and symposia
- urban praxis - reports on current developments in urban policy and related political events
- argument - this section will provide a forum for replies to articles published in the journal
- substantial book reviews and review articles.

In May 1977 the first book edited by the Research Committee will be published: Michael Harloe, editor, Captive Cities, Wiley Publishers, Boffins Lane, Chichester, Sussex, U.K.

The Committee has been preparing an issue of Current Sociology on Urban and Regional Development to be published in 1978. Elizabeth Lebas has been appointed editor of the issue which will contain trend reports from France, Great Britain, Italy, Eastern Europe, USA, Spain and possibly other countries.

After the Messina meeting, it was decided to re-organize the Committee into large national sub-groups. These will be responsible for organizing small meetings on a national or international basis, sponsoring comparative research studies, diffusing information about the other groups and the whole Research Committee activities. Three groups have already been formed with the following coordinators (elected by the group of members who initiated the national group, subject to a democratic verification at forthcoming plenary meetings):

Forthcoming activities:

No general meeting is foreseen for 1977. Two meetings will be organized by the American group: one in Santa Cruz, California on April 8-10, 1977, open only to members of the group; a second larger one (provisionally) later on where some international guests will be invited.

In York (January 4-8, 1977) the Centre for Environmental Studies organized the second seminar on Urban Change and Conflict (convened by M. Harloe and attended by 120 participants among whom some board members of the Committee). At this meeting the British group met for the first time and decided a preliminary program of activities.

The British and French groups are to organize various small discussion meetings through the year, some of them open to invited foreign guests.

Prof. Mirowski (Warsaw), fully sponsored by the Committee, will try to organize a meeting in Poland attended by Eastern European scholars, members of the board and a restricted number of other invited scholars. Through this meeting the Committee will try to establish an organized group in Eastern Europe.

The Committee will also sponsor the constitution of national groups in Italy, Spain, Germany and in any other region or nation where membership and interest are sufficiently large.

*Messina and Reggio Calabria Conference - April 1976 (International Conference on Social Problems of Urban and Regional Development):*

The conference was attended by more than 200 participants from 19 countries.



In the various sessions 48 papers and various oral contributions were presented. The conference was the second largest sociological meeting organized in Italy after the IV World Congress of Sociology (Stresa, 1959) and the first held in the South.

The arguments debated at the conference were among the most important themes regarding current societies: industrialization and urbanization, relations between rural and urban development, economic and political crisis, urban and local politics, regional underdevelopment and development.

Many of the papers given at the conference will be printed in various readers and some of them will be published in the new International Journal of Regional and Urban Development.

The main activity of the Committee has been the organization of the International Workshop on Comparative Ecological Analysis of Social Change, August 1-12, 1976, Ljubljana.

On the occasion of board meetings and Committee Business meetings held in Toronto in August 1974, it was decided to accept the proposition of Z. Mlinar to organize in August 1976, in Ljubljana, an international workshop on comparative ecological analysis of social change. The further activities of the board have centered on two main points: preparations for the next World Congress in Uppsala and activities in Western Europe to found further scholarly organizations in sociolinguistics.

The program for the Uppsala meeting in 1978 is being organized by Jonathan Pool at the following address:

In contrast to the impossible load of about 200 sociolinguistic papers prepared for the last meetings in Toronto, the Committee will reduce the load considerably. Pre-conferences in various countries are planned next year to allow for a certain amount of screening of the papers. The following sessions are planned for the Congress:

- Language and Sex
- Verbal and Non-Verbal Aspects of Face-to-Face Communication
- Language and the Mass Media
- The Sociology of Language Learning and Teaching

- The Scope, Goals, and Methods of Sociolinguistics
- Other Topics in Sociolinguistics
- Administrative session.

President Verdoodt participated at meetings held in Belgium, France, Germany and the Netherlands in order to create sociolinguistic sections in the framework of the national sociological associations in these countries. As a member of the editorial board of the International Journal of the Sociology of Language, he prepared a special issue on sociolinguistics in Belgium (to be published in 1977). He was also the senior editor (together with past President R. Kjolseth) of "Language in Sociology" containing 10 characteristic papers from the 180 sociolinguistic contributions presented in Toronto. The Editions Peeters in Louvain have published the volume.

The second Vice-President, Lluís Aracil, reports on the activities of the Grup Català de Sociolinguística, founded at his initiative in 1973, preparing the Language section of the forthcoming Congress of Catalan Culture (Barcelona, spring 1977). Changes in this area may be illustrated by the fact that the University of Barcelona has introduced Sociolinguistics as a recognized subject into its curriculum.

An action committee for the formation of a sociolinguistics section in the Deutsche Gesellschaft für Soziologie (Dittmar, Grathoff, Schütze) has been established as an initiative of the Committee in October 1976 in Bielefeld. Four conferences



and workshops on Face-to-Face Communication, Interpretive Methods, and Biographical Studies are planned by this group in 1977/78.

Other activities prepared by the Committee for 1977 and 1978 can be summarized as follows:

- Albert Verdoodt and Lluís Aracil are preparing an international sociolinguistic round table in Perpignan (France) July 24-30, 1977.

- Albert Verdoodt engaged the Committee in two UNESCO-sponsored research projects: "Clarifying Concepts and Criteria in Social Sciences" and "Sociolinguistic Problems of Migrant Workers".

*Report of Activities:*

"Sociotechnics" derives from an initiative of the section of Sociotechnics of the Polish Sociological Association. After having met for more than ten years with other Polish sociologists, Adam Podgorecki, the Chairman of this section, proposed in 1970 to the ISA the establishment of this Research Committee. Since this proposal has been accepted, there has been an attempt to locate social scientists throughout the world who are interested in the new topic of academic inquiry. In November 1973 these interested scholars met at Loughborough University, England. Their meeting served two purposes: it first provided a definition and determined the orientation of the new discipline; secondly, it specified the major problems in the field; and finally, it formally established the Research Committee on Sociotechnics of the ISA. The results of this initial meeting were later published in both English and German. The English edition, edited by Albert B. Cherns, was titled Sociotechnics (London: Malaby Press, 1976), and the German edition was edited by Joachim K.H.W. Schmidt and titled Planvolle Steuerung Gesellschaftlichen Handelns - Grundlegende Beiträge zur Gesellschaftstechnik und Gesellschaftsarchitektur (Opladen: Westdeutscher Verlag, 1975).

Both editions offer a selection of papers which were submitted for both editions, and both stressed the fact that sociologists are here dealing with a new methodology. Sociotechnics, or social engineering, has emerged as essentially a general theory of an efficient methodology of social action.

During the VIII World Congress of the ISA in Toronto in 1974, the Research Committee on Sociotechnics organized several sessions.

In 1975 the Committee scheduled an independent meeting in Warsaw, Poland, where scholars from 14 countries met to discuss problems of social values and social engineering. It can be stated that this conference was a complete success, and efforts are now being made to publish the proceedings and papers of this third conference on sociotechnics.

The English-language version is to be edited by Adam Podgorecki, and the German edition will be edited by Joachim K.H.W. Schmidt. (An Italian edition is still being negotiated). All the papers to be published focus on the questions of value and efficiency of social activities.

The next meeting of the Research Committee is planned for December 1977 in Rotterdam, the Netherlands. The theme of the conference will be "Planning, Legislation, and Freedom", and discussions are planned for the purpose of defining the proper curriculum for social engineering as it takes place in the university and prepares sociologists for the new career of sociotechnics. The chief organizer of this conference is Prof. Regina Hommes, Faculteit der Sociale Wetenschappen of the Erasmus University in Rotterdam.

Finally, we should note that Vol. 23, No. 1, of Current Sociology will soon appear; the issue is edited by Adam Podgorecki and devoted entirely to the new field of sociotechnics. However, since the material included in this volume was gathered before 1970 and contains a bibliography listing only publications dated through 1972, it is not necessarily representative of the present state of development in the field of sociotechnics.

*Report of Activities:*

The main activity of the Research Committee in 1976 was the Jerusalem Seminar on Mobility and Social Stratification, held April 28-30. The realization of this successful conference is mainly due to the initiative and organizational activities of Dov Weintraub and Judah Matras, Hebrew University, Jerusalem. Participants to the seminar came from Canada, Denmark, Federal Republic of Germany, Finland, France, Ireland, Israel, Italy, Nigeria, Sweden, Switzerland and the U.S.A. The work of the seminar referred to reports and discussion of results of ongoing research projects on mobility and social stratification in most of the countries represented, to theoretical and methodological problems and to comparative research in the field. Particular attention was given to the impressive quantity and quality of studies on stratification and mobility being done in Israel.

A conference of the Research Committee will take place in Dublin April 5-7, 1977. The theme of the meeting is not specific to any area of social stratification, but it is anticipated that continuing reports will be available from a number of national mobility studies. It is also hoped that one session might be devoted to a set of papers covering recent issues in the relationship between education and social mobility and that there will also be a number of papers addressing themselves to the integration of social mobility analyses and theories of stratification.

Before the next World Congress in Uppsala (1978) an additional two further meetings sponsored by the Research Committee are planned: one is offered by Prof. Caserman, to take place in Ljubljana (Yugoslavia), the other by Prof. Loetsch, to be organized in Berlin (GDR).

PAST MEETINGS

ISSC-MSH Symposium on Capitalism and the Rise of the National State in Europe, XVI to XVIII Centuries - Bellagio 14-17 October 1976.

The International Social Science Council and the Maison des Sciences de l'Homme in Paris agreed in 1975 to develop a joint program of Symposia on Innovative Works in the Social Sciences.

The first of these Symposia took place in October 1976 at the Villa Serbelloni at Bellagio. The Rockefeller Foundation had generously offered board and lodging at the Villa and travel funds had been provided by the Maison des Sciences de l'Homme and a number of National Research Councils.

The Symposium focused on two recent works on the macro-sociological interpretation of the distinctiveness of European history:

Perry Anderson's Lineages of the Absolutist State and Immanuel Wallerstein's The Modern World System.

The Symposium was directed by Fernand Braudel and Stein Rokkan. There were altogether 20 participants: 5 Scandinavians, 4 French, 3 from the U.S., 2 Italians, 2 Poles, one each from the FRG, Hungary, Turkey and the U.K.

JOURNALS

Language Problems and Language Planning is the title of a journal to be published beginning in 1977 by Mouton & Co. of the Hague and Paris. The editor is Richard E. Wood of Adelphi University, USA. The purpose of the journal will be to provide a forum for article-length studies, reviews, and review essays on problems and policies associated with language as a social phenomenon. Problems of language diversity, linguistic minorities and their rights, language in education, the standardization and development of languages, the role of language in economic planning, and language-related attitudes and behavior are examples of the topics that the journal will cover. It will particularly emphasize comparative studies, case studies with general significance, and studies of language problems that transcend the boundaries of a single country.

It will be an international journal in every sense. Its editorial committee will represent all parts of the world. The title of the journal will appear in several languages on the cover, and there will be no restriction on the language in which an author may propose a manuscript, except the ability of the editor to find competent reviewers. (Professor Wood himself reads 25 languages). Summaries in other languages, depending on the desired audience, will accompany articles, and the editorial office will also arrange for any article to be translated into any language for a moderate fee.

WORLD HEALTH ORGANIZATION

"On December 1, 1976 I attended an informal meeting called by the World Health Organization on the subject of Disability Prevention and Rehabilitation.

I represented the International Sociological Association in its capacity as a Non-Governmental Organization in official relations with WHO. Approximately 20 other NGOs were represented at this meeting. Representatives of the United Nations, UNESCO and the International Labor Organization were also present.

The major purpose of the meeting was to discuss ways and means to help implement the development of a new policy at WHO aimed at improved disability prevention and rehabilitation. This new policy is embodied in a resolution of WHO adopted at the twenty-ninth World Health Assembly (WHA 29.68, 20 May 1976) and further detailed in a document prepared by WHO(A29/INF.DOC/1, 28 April 1976). This document on Disability Prevention and Rehabilitation reviews the magnitude of the problem, present rehabilitation services, and proposes new guidelines in improving these services. The seriousness of the problem can be judged from the estimate that there are at least 400 million people or about 10% of the world population who are disabled. The problem is particularly severe in the developing world. The meeting in Geneva was called to seek the cooperation and support of such organizations as ours in improving services for the disabled and in the prevention of disability.

The meeting was opened by Dr. K.W. Newell, the Director of the Division of Strengthening Health Services at WHO. This was followed by the appointment of Mr. Norman Acton, Secretary General of Rehabilitation International as Chairman, Secretary and Rapporteur.

A presentation was made of the new WHO policy and program by Drs. Newell and Helander, as well as reports given by NGOs on ongoing projects in the developing world. A variety of substantive issues were discussed. Also discussed were ways in which NGOs could cooperate with WHO, other UN agencies and each other in implementing the goals of improved disability prevention and rehabilitation. I indicated the interest and the willingness of the ISA to consider cooperating in this endeavour, and particularly in helping to identify sociologists who might be interested and qualified to participate in joint studies with other organizations.

The participants decided that, at the outset, two problem areas might serve as foci for further discussions and collaborative efforts:

1. an evaluation study of present and alternative arrangements to provide preventive and rehabilitative services, with an emphasis on costs-benefits.
2. to study and attempt to outline feasible procedures to develop manpower around the needs of disabled persons.

It was further agreed that Mr. Acton would send to every participating or interested NGO (including the ISA) a more detailed statement of these two possible projects, and seek our reactions to these ideas.

Finally, a general statement of the meeting was proposed and drafted, and will also be sent to the ISA. It emphasizes, among other, that the WHO objectives are welcome, that the application of the principles enunciated by WHO must be done with flexibility because of the variety of circumstances and resources around the world, that an important task is to identify agents of change in communities, the need for more complete and detailed information, and the convening of two ad hoc study groups representing the major professional organizations in order to focus on the two problem areas mentioned above. I suggested that this statement include language to the effect that a greater effort be made to involve the participation of disabled persons themselves in any such studies.

This was adopted."
