# "Enhancing the role of medicine in the management of European health systems: implications for control, innovation and user voice" (COST Action IS0903)

This International Research Network is funded by the European Commission FP7 programme COST; see http://www.cost.eu/domains\_actions/isch/Actions/IS0903 (European Coordination in Science and Technology) and hosted at the Centre for Innovation in Health Management at the University of Leeds, UK. While the Action focuses on Europe, networking and collaboration includes also other countries. The main objective of this COST Action is to increase empirical, theoretical and policy relevant knowledge about the changing role of medical professionals in the management of healthcare. This Action is rooted in a number of recent trends in healthcare: the growing involvement of doctors in management and changes in medical education, training and career structures. These changes are assumed to be positive, leading to improvements in organization learning and control, innovation and user voice. However the evidence supporting such conclusions remains fragmented. While changes in the relationship between management and medicine have received some attention at national levels, there is less research adopting a rigorous, comparative, interdisciplinary perspective. Focusing on hospital doctors this COST Action aims to address these limitations to advance theoretical, empirical and policy relevant knowledge.

The joint work programme includes:

- Working group meetings
- Scientific workshops and seminars
- Short term scientific missions or exchange visits (STSM's)
- Training schools and research conferences
- Dissemination

In 2012 conferences will be held in June in Madrid and in November in Milan and additionally, workshops for PhD students, knowledge exchange with practitioners and special sessions at other academic conferences, like for instance at the next EHMA (European Health Management Association) Conference and the ISA RC52 Interim Conference (see announcement).

The Network is Chaired by Ian Kirkpatrick, Professor at the Centre for Innovation in Health Management, University of Leeds, UK. 
