Obituary

Political Sociology Loses a Great Scholar: Fred Riggs

Fred Riggs, a great political sociologist, passed away on February 3, 2008 in Honolulu at the age of 90. He was born in China and studied at the University of Nanking where he observed and experienced first-hand the enormous differences between Western and Chinese societies. After having taught at the University of Indiana, Bloomington, he went to the University of Hawaii in Honolulu. Fred was a prodigious scholar, publishing works like: *Administration*

in Developing Countries (1964), Thailand: The Modernization of a Bureaucratic Polity (1966), Prismatic Society (1973), Applied Prismatics (1978), and others. He co-authored with Giovanni Sartori and Henry Teune The Tower of Babel (1975). He chaired the IPSA Committee on Conceptual and Terminological Analyses (COCTA). His essays on Presidentialism versus Parliamentarianism, bureaucrats as a ruling class, or American exceptionalism could have only been written by this imaginative and innovative scholar, impregnated with a vast knowledge of comparative sociology. He will be remembered and we will keep learning from his outstanding works.
