Though all members are fully aware of the importance of a historical orientation in examining social issues of the day, it sometimes seems as though that vital perspective becomes marginalised in the desire for topicality and relevance – not just in relation to current social interventions but also in terms of an imagined future. We know of course that there is no natural break between past, present and future, and even more policy-oriented perspectives become more realistic and plausible through an understanding of social processes unfolding over time.

The board and officers of RC56 will endeavour to support members to develop and communicate their work. To this end we are exploring several initiatives that we hope will benefit members in their pursuit of historically-informed sociological accounts and explanations, including:

- Collaborating with other RCs and groups, such as the Norbert Elias Foundation, to organise and support conferences

- Pre-conference PhD workshops
- Online PhD workshops
- Mentorship programme to support early career researchers in terms of research paper revision and choice of journal for submission
- Compilation of a list of journals open to historical sociology
- Developing sub-groups within the RC concerned with particular research fields and interests
- Encouraging local and regional research networks, meetings, seminars, and symposia under the RC56 banner
- Sharing syllabi and teaching resources relevant to historical sociology
- Using social media platforms to publicise members' work and research activities

It will of course take time to develop these initiatives, but we urge members to communicate their own ideas and suggestions for RC56 to Fabio, Lucy and myself. The next ISA Forum will be hosted in Rabat, Morocco, in July 2025 and we encourage members to develop session proposals (the call for sessions will likely go out in Spring 2024). 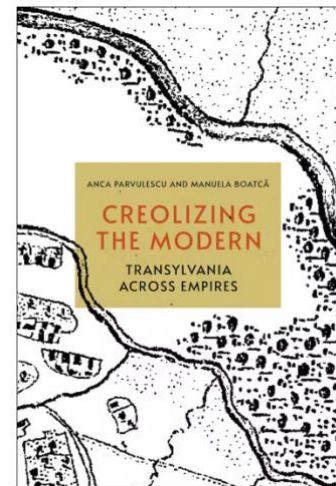
III Milestones and Achievements



Sujata Patel has been the 2021 Kerstin Hesselgren Visiting Professor, Umea University, Sweden; Distinguished Professor, Savitribai Phule Pune University; National Fellow at the Indian Institute of Advanced Studies (IIAS), Shimla and a teacher of sociology at the Universities of Hyderabad, Pune and SNTD Women's University. Her work on modernity and global social theory, history of sociology/social sciences, urbanization and city-formation, social movements, gender construction, and caste and class formation in India combines an historical sensibility with four perspectives-Marxism, feminism, spatial studies and post structuralism. She has been associated in various capacities with the International Sociological Association (ISA) and has been its first Vice President for National Associations (2002-2006). She was the President of Indian Sociological Society from January 2016 to December 2017.
